Minutes of Meeting  
Wednesday, January 25, 2012

**The meeting was called to order at 8:35 am by Vice Chair Veronica Turner:**

The meeting was opened by the Vice Chair, Delegate Veronica Turner.

- **PG 401-12 – Prince George's County - Common Ownership Communities - Fee for Mandatory Administrative Hearings-** The Vice Chair introduced the bill and read the summary. She explained that the bill was supported by the Prince George's County Executive's Office. Delegate Howard introduced a favorable motion on the bill which was seconded by Delegate Ivey. **The favorable motion passed unopposed (4 yea, 0 nay, 1 absent). The bill will be reported to the full Delegation on 1/27/12.**
- **PG 403-12 – Prince George's County Board of Education - Recycling Program - School Facilities.** The Vice Chair introduced the bill and read the summary. The Vice Chair recognized the bill sponsor, Delegate Summers. Delegate Proctor introduced a favorable motion and the bill was seconded by Delegate Howard. **The favorable motion was passed unopposed. (4 yea, 0 nay, 2 absent). The bill will be heard on 1/27/12.**
- **PG 404-12 – Prince George's County - Special Elections - Reduction of Polling Places.** The Vice Chair introduced the bill and read the summary. Delegate Ivey mentioned that it was a great way to save money. She continued to say that it authorizes Prince George's board of elections to reduce the number of polling places if need be. She also expressed that the public would be made aware of the changes. Delegate Howard

introduced a favorable motion and the bill was seconded by Delegate Proctor. **The favorable motion was passed unopposed. (4 yea, 0 nay, 2 absent). The bill will be heard on 1/27/12.**

- **PG 405-12 – Prince George's County - Board of Education - Operation of Schools - Year-Round Basis.** The Vice Chair introduced the bill and read the summary. Delegate Howard asked if the bill was supported by school board, which it was. Delegate Ivey offered a favorable motion which was seconded by Delegate Proctor. **The favorable motion was passed unopposed. (4 yea, 0 nay, 2 absent). The bill will be heard on 1/27/12.**
- **PG 406-11 – Prince George's County - Drug Free School Zones - Hotline Number on Signs.** The Vice Chair introduced the bill and read the summary. Delegate Howard asked when the bill would start. Delegate Ivey answered only when they need to replace an old sign. She also stated that it will be at the entrances of all the schools. Delegate Howard made a favorable motion and was seconded by Delegate Ivey. **The favorable motion was passed unopposed. (4 yea, 0 nay, 2 absent). The bill will be heard on 1/27/12.**
