5 FOR the purpose of requiring the Prince George’s County public school system to publish
6 prominently on its website links to certain expense forms filed by members of the
7 Prince George’s County Board of Education; requiring certain expense forms filed by
8 members of the Prince George’s County Board of Education to be designated as
9 certain public records available to any applicant immediately on request and
10 included on a certain list posted on the school system’s website; and generally
11 relating to the members of the Prince George’s County Board of Education.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
4 That the Laws of Maryland read as follows:

5 **Article – Education**

6 **4–404.**

7 **(A) THE PRINCE GEORGE’S COUNTY PUBLIC SCHOOL SYSTEM SHALL**
8 **PUBLISH PROMINENTLY ON ITS WEBSITE A LINK TO EACH EXPENSE FORM FILED BY**
9 **A MEMBER OF THE COUNTY BOARD FOR REIMBURSEMENT BY THE SCHOOL SYSTEM.**

10 **(B) EACH EXPENSE FORM FILED BY A MEMBER OF THE COUNTY BOARD FOR**
11 **REIMBURSEMENT BY THE PRINCE GEORGE’S COUNTY PUBLIC SCHOOL SYSTEM**
12 **SHALL BE:**

13 **(1) DESIGNATED AS A PUBLIC RECORD AVAILABLE TO ANY**
14 **APPLICANT IMMEDIATELY ON REQUEST UNDER § 4–201(C)(1) OF THE GENERAL**
15 **PROVISIONS ARTICLE; AND**

16 **(2) LISTED ON THE CURRENT LIST OF TYPES OF PUBLIC RECORDS**
17 **DESIGNATED AS AVAILABLE TO ANY APPLICANT IMMEDIATELY ON REQUEST UNDER**
18 **§ 4–201(C)(2) OF THE GENERAL PROVISIONS ARTICLE THAT IS POSTED ON THE**
19 **WEBSITE OF THE PRINCE GEORGE’S COUNTY PUBLIC SCHOOL SYSTEM.**

20 **Article – General Provisions**

21 **4–201.**

22 **(c) Each official custodian shall:**

23 **(1) designate types of public records of the governmental unit that are to**
24 **be made available to any applicant immediately on request; and**

25 **(2) maintain a current list of the types of public records that have been**
26 **designated as available to any applicant immediately on request.**

1 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
2 October 1, 2019.
